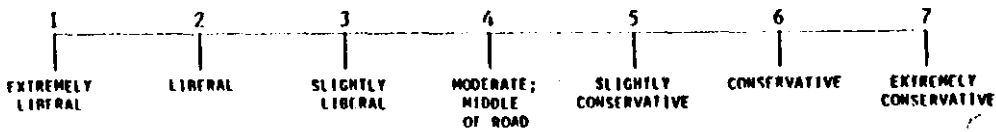

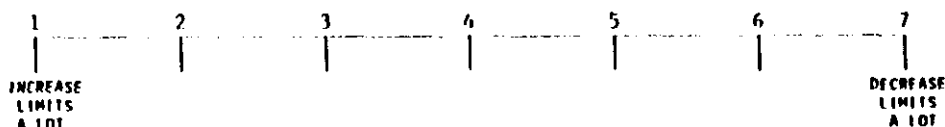

JOB AND GOOD STANDARD OF LIVING



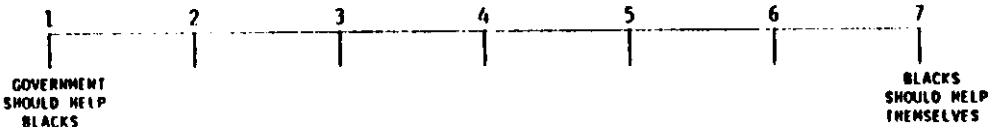

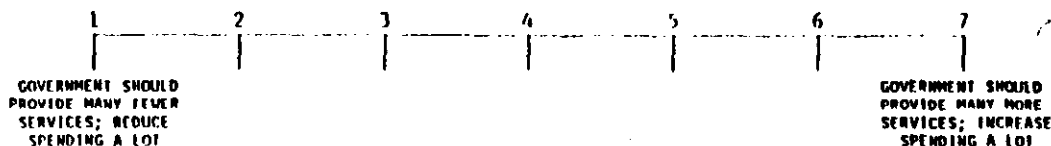
